

## CONDITIONS FOR USE OF RBYC CLUB RIB

The RBYC (Cadets) has two club RIBs ("Progress" and "Red Devil"). Please see RIB guidance for details. This Agreement sets out the conditions under which a rib can be used. The payment for the use of the RIB or RIBs will be agreed in advance by the club.

### *Conditions of Use*

1. The helmsman will have responsibility for all aspects of looking after the boat for the duration of its period of use, ensuring it is used safely and properly, kept in a clean and tidy condition and properly secured at the end of each session of use.
2. In the event of persistent misuse or any occasion of gross misuse of boat, the Club may terminate this agreement at any time without any refund of monies paid.
3. The boat is only available for use on the water as agreed with the club. Under no circumstances can it be used at any other time.
4. Any loss / damage found at the start of the hire period must be noted on this form. The helmsman shall reimburse the club for any loss or damage caused during their use of the boat or third party and shall either:
  - Pay the full amount for replacement parts/repair costs or
  - In the event of an insurance claim, pay the amount of the excess applicable whichever is less 7.
5. The helmsman has read and agrees to abide by the club RIB guidance, in particular to all aspects in relation to safety.
6. It remains the responsibility of the helmsman to decide whether conditions are suitable to use the boat, to satisfy themselves that the boat is seaworthy, and that they are sufficiently competent to cope with the prevailing conditions. RBYC can accept no responsibility for the conduct and safety of the boat and crew during its use.
7. Where conditions are considered marginal or unsuitable for the boat's use, the club may refuse permission for the boat to be used or launched, or if already afloat insist that they return to shore.
8. Completion of this Agreement Form constitutes acknowledgement and acceptance of these conditions of use.

**Declaration:** I have read and agree to abide by all of the Conditions of Use at all times. Further I agree to hold Royal Burnham Yacht Club free of any liability for damages that occur to the helmsman, crew or any sailor/other involved in the activity for which the boat is being used, for any causes arising from the operation and control of the boat and its equipment.
